Postdocs Old and New

This summer saw the departure of Kelly Bedard, the first CILN Postdoc, who has been working at McMaster for the past two years. Kelly leaves for warmer climes as she is starting a job a Claremont College in California. We wish her the best with her research and career and hope to maintain CILN links in the years ahead.

We are pleased to welcome the new CILN Postdoc, Isaac Rischall, also appointed for a two-year term. Isaac was born and raised in St. Paul, Minnesota and received his bachelor of arts in mathematics and economics from Carleton College in Northfield, Minnesota. He attended the University of Wisconsin, Madison, for graduate work in Economics and recently received his Ph.D. His doctoral research dealt with the consequences of different human capital investments. The first chapter ascertained whether single mothers increase the benefits or the earnings they receive by migrating. The second chapter addressed the effect of studying in high school on future earnings. The third chapter separated out the returns to education and the returns to skill from the intergenerational income mobility coefficient.

In addition to this work, Isaac is currently working on a paper (with Jim Andreoni and Eleanor Brown) that examines household bargaining using data from the Independent Sector Survey on Giving. This research studies how changes in earnings across family members affect who is responsible for the charity decisions. While at McMaster. he intends to use microdata from the Canadian Self-Sufficiency Project to see how time limits on welfare participation in the United States will affect training decisions of single mothers.
