CILN 1996-2000

CILN's five year term ended in December 2000. renewed team of program directors and researchers made application to SSHRC for a further five year's of funding under the Major Collaborative Research Initiative (MCRI) program. However, this application was turned down, the principal grounds being that CILN was insufficiently interdisciplinary. On September 24-25, 2000, CILN held its Third Major Conference in Burlington, Ontario. Ninety-one individuals from around the world attended the conference, with participants drawn from economics, political science, sociology and related fields. In addition to academics, attendees represented a number of prominent policy organizations, including the Bank of Canada, Statistics Canada, Human Resources Development Canada, Commission for Labor Cooperation, and the Urban Institute.
